ABOUT DRIVE+

Drive+ is an opportunity for automotive tier-1 suppliers and supplier associations to get engaged in a systematic dialogue about common sustainability challenges and to collaborate to find joint solutions. By becoming an associated partner in Drive+, suppliers get **first-hand information** from and access to **Drive Sustainability**. They are consulted on the topics discussed by the OEM partners and can learn together with the OEMs about policies, due diligence and how to create impact on the ground. Drive+ engagement helps suppliers **meet Drive Sustainability expectations** and cascade them in their own supply chain.



DIALOGUE

Structured follow up and feedback to Drive Sustainability partners.

- **Suppliers' consultation**
Have your say & contribute to the direction set by Drive Sustainability partners. Drive will offer at least 2 consultations & feedback webinars per year on key topics, like carbon footprint and raw materials standards.
- **Access to the Self-Assessment Questionnaire (SAQ) user group**
1-2 consultations per year with feedback options.
- **Updates after each of the 4 Drive Sustainability Steering Committee meetings**
- **Access to a Drive+ extranet**
For intelligence, information and updates about the Drive Sustainability meetings.
- **Recognition as Associated Partner of Drive Sustainability.**



LEARNING & SHARING

On key sustainability topics in the automotive supply chain.

- **Thematic Workshops**
Participate to the 4 open thematic virtual workshops hosted by CSR Europe throughout the year on topics like supply chain transparency, circular economy, sustainability policies and regulations.
- **Physical meetings**
Virtual webinars are practical but are not the ideal solution for networking and sharing / learning between participants. If possible, some physical meetings will be proposed as an alternative to the members.
- **The events will bring together Drive+ and Drive Sustainability members.**



DRIVE SUSTAINABILITY TOOLBOX

Fulfilling Drive requirements and cascading in the supply chain.

- **Opportunity to send your suppliers to trainings** organized by Drive Sustainability at same rate applied to DS members (*). You will also have voice into the choice of training countries.
 - **Access to other tools developed by Drive Sustainability (TBC)**
e.g. full access to the Raw material Outlook (RMO).

What are the Conditions for Joining Drive+?

1. Commitment

We expect engagement and willingness to contribute to the Drive Sustainability mission and its strategic ambitions towards a sustainable automotive supply chain.

- By signing the Drive+ membership contract, the supplier accepts to support the **Automotive Guiding Principles**.

2. Anti-trust policy

Drive+ members accept to adhere to the same anti-trust policy applied in the Drive Sustainability group. The anti-trust policy is part of the Drive+ contract.

3. Contract (for suppliers)

The membership fee is paid by the supplier on a yearly basis and the amount depends on the turnover of the company:

- 1000 € if turnover < 5 million EUR
- 2500 € if turnover 5 – 200 million EUR
- 5000 € if turnover > 200 million EUR

4. Memorandum of Understanding (for supplier associations)

Supplier associations can join Drive+ for free.
